The purpose of an IPG is to help your program ideas become reality:

The Beaty ECS PTA has set aside funds for workshops, seminars, and various types of continuing education for teachers in areas that bring new information and programs to your classroom. Grants are also awarded for materials that are specific to the introduction of a new classroom program.

The application process is simple:

If approved by Ms. Vaughan, the committee will review the request and follow-up to let you know if your grant has been approved. The committee will send in any registration forms with payment. Substitute pay will be included, if necessary.

We eagerly await your requests and encourage you to apply. There are no restrictions or limits to the number of applications, with one exception: please limit attendance to a given seminar to two teachers per neighborhood unless approved by Ms. Vaughan.
